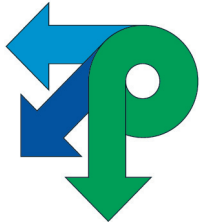

Integration Overview

The integration between Triple Point's Commodity XL platform and Oracle's E-Business Suite provides customers with a seamless solution for physical commodity management and streamlined workflow supporting the entire lifecycle from requisition to delivery and settlement. More specifically, the validated integration supports receiving a requisition for trading of a commodity from E-Business Suite; execution of the requisition through a trade within Commodity XL; Commodity XL sending the consummated trade to E-Business Suite for creation of the purchase order; E-Business Suite sending information of actual commodity received to Commodity XL to update the positions; and Commodity XL sending final pricing information to E-Business Suite for invoicing and settlement purposes.

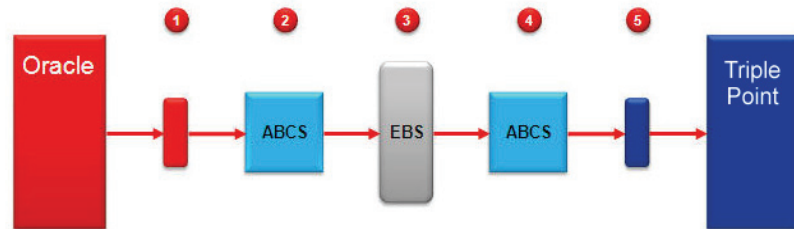

Integration Details

The components being validated in the Commodity XL/Oracle E-Business Suite integration include:

- Demand/ Supply Integration
- Contract Integration
- Delivery Integration
- Final Pricing/Settlement Integration

Demand Integration Functional Overview:



1. **Oracle Requisition Requester Service** listens for new Oracle Requisitions and invokes Requisition Requester Application Business Connector Service (ABCS) via WSDL interface. No transformation is performed.
2. **Requisition Requester ABCS** transforms Oracle Requisition into Canonical Requisition and invokes Requisition Enterprise Business Service (EBS) via WSDL interface. Canonical Requisition is enriched as needed.
3. **Requisition EBS** routes Canonical Requisition to Requisition Provider ABCS via WSDL interface based on operation such as create, update, query, etc. No transformation is performed.
4. **Requisition Provider ABCS** transforms Canonical Requisition into Triple Point Requisition and invokes Triple Point Requisition Provider Service via WSDL interface.
5. **Triple Point Requisition Provider Service** invokes Triple Point interface service via appropriate mechanism. No transformation is performed.

NOTE : All integration types listed above follow the same methodology.
